## CAMPING RULES

### **CHECK-IN:**

on arrival, all guests are required to fill in the "notify schedule" and leave their documents at the reception for registration. Everyone will receive his **personal pass** -**an ID bracelet**- **which has to be visibly worn during your stay in the camping-village.** 

- The admission of people or things is subject to the discretion of the management of the campsite and naturally will involve the acceptance of tariffs in force and the complete observing of regulations, which has to be totally accepted by everyone. Rules can be changed from the direction at any time.
- All children must be with their parents, older relatives or other adults who will be responsible for them.
- People in the camping site without permission will be reported for housebreaking under the Italian law art. 614. Anyone breaking any of the rules listed here will be asked to leave immediately.
- The reception is open from 8.00 a.m. to 10.00 p.m. Your emplacement is assigned by the campsite who will inform you about the rules which you have to conform during your stay. Customers wishing to change emplacement or extend their stay may do it only after getting permission from the campsite.

#### SILENCETIME:

the gate is closed from 02.00 p.m. to 04.00 p.m and from 12.00 p.m to 07.30 a.m. Loud noises and the usage of cars, motorcycles or bicycles on site, packing or unpacking tents, listen to loud radios or TV, washing dishes is forbidden during these hours; therefore to avoid inconvenience, customers are advised to plan arrivals and departures in advance.

### **BIKES:**

the usage of bicycles inside the camping site is allowed only dead slow and during the authorized hours.

### **EMPLACEMENTS:**

the emplacement is delimited and all equipment included the car should be kept in it, except for special agreements with the management. Equipment may include one car + one caravan, one car or motorbike + one tent, one camper; anything else will be considered extra according to the price list. **On the ground** only **breathable** tarpaulin and better if fire resistant.

- The electrical power supplied is 6 A max and responsibilities of the management are limited to the linking system to the network. It is not allowed to make any interferences on the electrical providers.
- The cables to the electrical providers are allowed only fireproof, no joining, in conformity with e.e.c.

## **FACILITIES:**

usage of campsite facilities is allowed in the manner and at the times established by the management. In particular, washing facilities will be open progressively, related to the number of people staying on site. For the usage of the swimming pool, customers are advised to respect the rules posted up on its entrance.

- Customers must respect all campsite equipment and use it sensibly, in particular washing facilities. Parents are recommended to keep watching children when using facilities. The campsite will not be held responsible for accidents resulting from this rule being broken.

## ANIMALS:

pets are allowed on site only after permission from the management and only in special sites. The owner must take care of animal's hygiene (outside the camping for their daily needs) and rigorously keep them on a leash. Animals have to have their health certificate and the owners must provide themselves with shovels and sweeper and make sure that the animals do not disturb other customers. Animals are not allowed in the swimming pool area, in the beach and in the playground.

## **ENVIROMENT PROTECTION:**

it is forbidden for customers to damage the vegetation on site in any way, to throw boiling water or detergents over plants, to attach strings, laces or water containers to the plants or to light fires (ex.: citronelle...). Gas grill is permitted, for coal BBQ has to be used the equipped area. Furthermore the marking of emplacement boundaries with fences or other (as for example, tracks or ditches around them) etc is forbidden. Camping guests need to have their own laundry rack.

- Dishes and clothes must be washed in the right washing up sink, with moderate use of water.
- Recycling must be deposited in the right containers located in the eco-island inside the camping.

## DAILY VISITORS: -from year 2020 not allowed anymore -

visitors are allowed only after permission and after identification documents have been handed over; after an hour they must pay the listed rate. Please note that customers will be held responsible for the behavior of their guest.

## **SECURITY:**

- -we inform visitors and customers that in this camping-village is working an overseeing tvcc-system, the recording and the treatment of personal date take place respecting the rules in the European law UE 2016/679 because of security and of the patrimony wealth of the camping-village Eurcamping as well as of others present there for any reason.
- -the campsite must be notified immediately if a customer develops an infections disease.
- -bad behavior is not allowed.

## This rules and regulation are handed to the guest on arrival and are pinned up at the entrance.

The staff is authorized to make regulations be observed and to mark out to management those who don't observe them. On the management opinion, non observance of such rules and a behavior which damages the harmony and the spirit of holiday, may be thrown out from the camping, as undesired guest.
